The provisions of 10 USC 12731(a)(3) require you to perform your last six years of qualifying service in other than a regular component, the Fleet Reserve or the Fleet Marine Corps Reserve. Therefore, as a member of the Army National Guard, to be eligible for issuance of Notification of Eligibility for Retired Pay at Age 60, you must earn at least 50 retirement points during each of the next zero anniversary retirement years. When you meet these requirements, you will be issued the notification within one year after 2009/10/13.
